The Hon Justice John Digby is a Director and Treasurer of the Australian Academy of Law. His Honour was appointed to the Supreme Court of Victoria in 2012. His Honour is an alumni of the Melbourne Law School and been a Member of the Standing Committee for the Masters Course since 1998, has lectured in the Masters Program in International Construction Law and International Arbitration since 2002 and has been a Senior Fellow of the Melbourne University Law School since 2005. ABOUT THE AUSTRALIAN ACADEMY OF LAW

Launched in 2007 by Her Excellency, Ms Quentin Bryce AC CVO, then Governor of Queensland and a Foundation Fellow of the Australian Academy of Law (AAL), the AAL is the fifth learned Academy in Australia and is the culmination of a process begun with the Australian Law Reform Commission's landmark report, *Managing Justice: a review of the federal civil justice system* (ALRC 89, 2000).
